**From the South:** I-85 (N) to Exit 12B. Follow Rt 58 (W) to Rt 4. Turn left onto Rt 4 (Exxon Station on left). Follow Rt 4 approximately 5 miles . Entrance to Dick Cross Wildlife Management Area on left immediately after Pino's Italian Restaurant.
