- Exit 20 South from I-64
- Thru Scottsville VA
- Cross Slate River Bridge
- Turn right on 649 , or Slate River Mill Rd
- Pass 658 , Saint Andrews Church Rd
- Go thru wooded area When at wooden fence on left look for entrance gate on left; There will be dog signs at gate

Directions from I-64 at Zion Crossroads and Rt. 15

- south on 15 thru Fork Union and cross James River Bridge
- Go thru Dillwyn to Rt 60.at Sprouses' Corner
- Follow Rt 60 west thru Buckingham Courthouse (35 mph)
- Just after Court House, turn right on 648 or Hall Rd
- Road narrows with STOP SIGN at fork
- Go right on 649 or Slate River Mill Rd
- Go half mile to gate on right. There will be dog signs at gate

Directions from 460 at Farmville
