- All levels open to all AKC registered pointing breeds
- The Hunting Test is held under the Rules and Regulations of the American Kennel Club. This club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
- Approved AKC Tracking Collars are permitted.
- Bitches in season are not eligible to enter and are not allowed on the grounds
- A separate entry form is required for each dog
- A signed waiver (included with the premium) is required for each exhibitor prior to closing
- An acceptable article of Blaze Orange must be worn
- Virginia law requires that participants age 16 and over must have a valid VA hunting license (or a valid license from their own state) in their possession.
- The MH/SH/JH judges will be on horseback or ATV
- Prizes: Qualifying ribbons and Special ribbons for dogs completing titles.
- Course: Master Hunter & Senior Hunter will run on one course.
 - : Junior Hunter will run on a separate course
- Birds: JH level will have quail, MH/SH quail
- <u>Waiver:</u> Participation in the hunt test either through entering or observance constitutes a waiver of liability to the Northern Virginia Brittany Club, its officers, directors and members, i.e., they are in no way responsible and cannot be held liable for any accidents involving anyone attending the hunt test, their horses, dogs, birds and /or equipment. No loose dogs on the event grounds except during the running of their brace. Participant vehicles are permitted only in the designated parking areas.




