COURSES, BIRDS, CONDITIONS, ETC.

- All stakes to be run on a single course without a bird field. Native and liberated quail or other game birds will be used.
- Blank pistols will be fired on pointed birds EXCEPT that in all puppy stakes it shall be at exhibitor's discretion. Only a blank pistol incapable of firing live ammunition may be used by handlers.
- Stakes with less than four (4) entries will be cancelled and entry fees returned.
- The use of AKC approved tracking collars will be permitted in accordance with American Kennel Club rules.
- Entries limited to number of dogs that can be run during available daylight hours and entries will close when that limit is reached if this occurs prior to the specified closing time.
- Bitches in season are allowed to run in Amateur Limited Gun Dog. Bitches in season are NOT allowed to run in any other stake.

SCRATCH POLICY

Full refund will be made prior to the drawings. After the drawings are held, only bitches in season, injury, illness, or death with a veterinarian's statement (Chapter 1, Sec 5), shall receive a full refund. The Field Trial Secretary must receive the veterinarian's statement within 10 working days after the event in order to receive a full refund.
